- attends and chairs all ASRL Committee meetings; and

The Secretary:

- prepare the Agenda for all Committee and General Meetings of the Association
- record and prepare minutes of the proceedings of all meetings of the Committee and the Association and use his/her best endeavours to distribute these minutes to the members promptly from the date of the meeting.
- regularly report on the activities of and issues relating to the Association.
